### EECBG Program Eligible Uses of Funds

- Develop an Energy Efficiency and Conservation Strategy (EECS)
- Technical consultant services to develop EECS
- 3. Residential & commercial building audits
- 4. Establish financial incentive programs for energy efficiency improvements
- Provide grants to nonprofit organizations for energy efficiency retrofits
- Develop or implement programs to conserve energy used in transportation
- Develop or implement building codes and inspection services
- 8. Implement energy distribution technologies
- Develop public education programs to increase participation and efficiency rates for recycling programs
- Purchase or implement technologies that reduce and capture methane or other greenhouse gases generated by landfills
- Replacement of traffic signals and street lighting with energy efficient lighting technologies
- 12. Implement or install in any government building on-site renewable energy technology (solar, wind, fuel cells, biomass)
- 13. Electric vehicle fleets or charging infrastructure
- 14. Programs for Financing, Purchasing, and Installing Energy Efficiency, Renewable Energy, and Zero-Emission Transportation (and associated infrastructure) Measures
